1. The Government of Tanzania has received funds from DFID towards the cost of construction of Kisesse-Sauna Bridge at Kondoza District Council roads during the financial year 2016/2017. It is intended that part of the proceeds of the fund will be used to cover for eligible payments under the contracts for which this invitation for bids is issued.
2. The **KONDOZA DISTRICT COUNCIL** now invites sealed bids from eligible Civil contractors registered in **Class III and above** as per respective requirement listed below with approximate major quantities of works

Bidding will be conducted through the National Competitive Bidding (NCB) procedures specified in the Public Procurement (Goods, Works, Non Consultant Service and Disposal of Public Assets by Tender) Regulations, 2013 - Government Notice No. 446 and is open to all Bidders as defined in the Regulations
5. Interested eligible Bidders may obtain further information from and inspect the Bidding Documents at the office of the **District Tender board Secretary, Kondoza District Council office No. 50** from **8:00am to 3:30Pm** on Mondays to Fridays inclusive, except on public holidays.

6. A complete set of Bidding Document(s) in **English** Language and additional sets may be purchased by interested Bidders on the submission of a written application to the address given under paragraph 5 above and upon payment of a non-refundable fee of **Tshs.150,000/=One hundred fifty thousand Only**. The Payment should be by Cash payable to **District Executive Director, Kondoa District Council**.
7. All Tenders must be accompanied by a bid securing declaration in the format provided in the Bidding documents.
8. The Bidder at his own cost make site visit for the project. The site visit is scheduled to be conducted on **15-18/03/2017** starting at **09.30** am, from the office of District Engineer Kondoa District Council.

All bids in **one** original plus **three (3)** copies, properly filled in, and enclosed in plain envelopes must be delivered to the Secretary District Council Tender Board, P.O.Box 1 Kondoa on or before **Wednesday,30<sup>th</sup>March,2017 at 10.30 A.m Local hours**. Bids will be opened promptly thereafter in public and in the presence of all Bidders' representatives who choose to attend in the opening ceremony at **Kondoalrangi Conference Hall**.
10. Late bids, portion of bids, electronic bids, and bids not received, bids not opened and not read out in public at the bid opening ceremony shall not be accepted for evaluation irrespective of the circumstance.
